### 3. ANNUAL REPORT presentation by the Chair – Kathleen Broderick

## 4. ANNUAL REPORT presentation by the Executive Director - Linda Daniels

An outline of the Foundation's activities and objectives achieved throughout the year was presented under the five key areas of:

- 1. Community participation contributing to physical and social well-being;
- 2. Development of opportunities for tourism, employment and education;
- 3. Protection of the natural, cultural and heritage values of the Track;
- 4. Attraction of funds and other resources; and
- 5. Advocacy for the Track

- The Foundation is in a strong financial position with high liquidity.
